LODGING (as of June 2017): (Not endorsed by Air Mobility Command or the USAF)

Kanto Lodge (Yokota): DSN 224-2002; pricing is: \$60.00 (Single Quarters), \$63.00 (TLF), \$63 (Large TLF, \$10 pet fee), \$69.00 (DV), \$75.00 (General's suite)

New Sanno Hotel (Downtown Tokyo): DSN 229-7121, Comm. 03-3440-7871 ext. 7121; prices vary between \$50-\$100 depending on pay grade and status. Bus departs Kanto Lodge at 0930 for \$8 to \$10 depending on status.

Tama Lodge (Tama, Japan): DSN 224-3409, Comm. 011-81-42-377-7009; Main Lodge and Cabin rates vary between \$48-\$195 depending on room, rank, and status. Approximately 1 hour trip by car or 1 hour trip by train (times may vary); price varies weekday vs weekend.

The Hardy Barracks (Downtown Tokyo): DSN 229-3270, Comm. 011-81-3-6385-3270; \$35 room rate with additional \$5 for each family member. 2 hour trip by car with 1300 Yen in tolls, 72 minutes by train for approximately 830 Yen.

Toyoko Inn (Downtown Tokyo): Comm. 042-553-1045, Room rates vary from 5,980 yen to 10,380 yen. Located next to Fussa Train Station, 10 Minute walk out Fussa Gate.

Tachikawa Grand (Downtown Tokyo): Comm. 042-525-1121, Room rates vary between 13,125 yen to 94,500 yen. 15 minute trip by train for approximately 160 Yen.

GROUND TRANSPORTATION: (Not endorsed by Air Mobility Command or the USAF)

Base Shuttle (Kanto express): Operates M-F 0600-2000, Weekends/Holidays 0800-2000, and a modified route during exercises.

Force Support Squadron (FSS) Shuttle: Operates daily between Yokota, New Sanno Hotel and Narita IAP. Please contact FSS at 225-7720 for detailed information. Pricing for Narita IAP shuttle is \$40.00 (leisure or TDY travel).

Kanto Lodge Shuttle: Operates daily 0400-1200 and 1300-2130 depending on driver availability. Contact DSN: 224-2000/2002

Taxi: The only currency accepted is Japanese Yen. Contact 012-074-1158 from a local phone. This service speaks little to no English. When calling please provide your name, pick up point, and destination. Taxi will not come on base.

AMC GRAM PASSENGER TRAVEL INFORMATION**PRICING:**

- Head Tax Fee: \$18.00 & Federal Inspection Fee: \$16.46 (Only for Patriot Express from OCONUS to CONUS)
- Flight Meals: \$5.55 (Organic Aircraft)
- Excess Baggage Fee: Based off of destination (Space-Required passengers only)
- Pet Fee: Based off of destination (Space-Required passengers traveling on PCS orders only)

CUSTOMS:

Military Customs and Immigration Concerns: For Non-SOFA status passengers (retired military personnel, Japanese passport holders, diplomatic passport holders, DOD civilians not stationed in Japan, and dependents not stationed in Japan traveling without their sponsor) entering Yokota AB, a visit to the Government of Japan (GOJ) Customs and Immigration Office is required upon arrival. Arriving passengers will be escorted by a Military Customs Official to the GOJ office, which is open daily from 0500-2200 hrs. It is the departing passenger's responsibility to process out of GOJ prior to departing on an AMC flight. If Non-SOFA passengers will be departing before GOJ opens, they may process out of Japan the day prior in order to catch their flight. ALL passengers with non-SOFA status are required to be stamped out of the country prior to competing for seats at the Space Available roll call.

FAMILY LOUNGE:

A "Family Lounge" is located inside the passenger terminal for all passengers traveling with children. Parents are reminded that children must be supervised at all times due to safety concerns.

UNIFORM WEAR:

Unless otherwise directed by the Foreign Clearance Guide, the wear of uniforms on AMC owned or controlled flights are governed by your respective branch of service. Passengers are reminded that open toed and open heeled shoes (including 5 finger/toe shoes) are not allowed on organic aircraft.

PASSENGERS WITH NON-APPARENT HANDICAPS:

Passengers with non-apparent handicaps including hearing, asthma, or pacemakers should advise a passenger service agent during check-in. Passengers with a handicap preventing movement under their own power are not permitted aboard AMC aircraft.

AMC NO SMOKING/TOBACCO USE POLICY:

The use of tobacco products is prohibited on all AMC-owned or controlled aircrafts. Thank you for your cooperation.

BAGGAGE ALLOWANCE:

All passengers are authorized two pieces of checked baggage weighing no more than 70 lbs each. Each piece must also not exceed 62 linear inches (length + width + height).
