USO Open for Business: In January, the USO opened its temporary center in Tower 2080 (across from the Library). They will remain at this location until their permanent center is ready later this year. Services provided by the Center are free of charge to all active duty members and their families, military retirees and their families and surviving spouses.

A couple of the RAO staff paid a visit to the USO center last week and were given a tour of the facility by the Center's Operations Specialist, Ms. Ashley Phillips. The center is currently opened Monday, Friday, Saturday and Sunday from 10AM to 7PM, and Tuesday, Wednesday and Thursday from 10AM to 10PM. Ms. Phillips said the goal is to stay open daily from 10AM to 10PM. With the exception of a couple of positions, the center is manned by volunteers.

A host of services are currently provided such as Hulu, Netflix, Apple TV, computer games, free snacks and drinks, a lounge to relax in, internet access via computer terminals, and free Wi-Fi to connect your own devices. Stop by the Center and talk to the staff to see what else is provided or that you may want to see provided. You can also visit the USO Facebook page at USO Yokota to see what events are being planned and for changes in the hours of operation.

The USO provides the center and its services free of charge to the Yokota Community, but it requires the help of volunteers. Yokota Tax Center is Filing Returns:

As mentioned in our previous newsletter, the Yokota Tax Center opened for business on 30 January and will continue preparing and electronically filing tax returns until 15 June which is the last day filers living overseas can file without requesting an extension.

Tax returns are prepared free of charge for active duty, military retirees, widows, and civilian employees. The operating hours are Monday through Thursday. Closed during holidays and exercises. Morning appointment schedule - 0800, 0910, 1020 Closed for Lunch - 1130-1230 Afternoon appointment schedule - 1230, 1440, 1550

Telephone numbers to call for an appointment: DSN 225-4926/4927, from off base 552-2510 ext. 54926/54927 The available appointment slots each day are based on the number of volunteers that will be working that they. As the tax season approaches the April 18th (This is not a typo, see below) filing deadline, the number of clients wanting appointments will increase. Please schedule your appointment as soon as possible.

The regular tax return filing deadline is April 15. However, due to the Washington D.C. Emancipation Day holiday falling on a weekend for the second year in a row, the tax

filing date has been moved to Tuesday April 18th.

U.S. Citizens and others who are required to file a U.S. tax return and are living overseas receive and automatic 60-day extension to file a tax return. However, the caveat here is if you think you are going to owe any taxes for the 2016 tax year, you must at least pay the taxes due by the April 18th deadline. If not, you could incur a penalty in addition to the taxes owed. *(Source: Yokota Tax Center, IRS.gov)*

Survivor Benefit Plan (SBP) Notes:

A Spouse Acquired after Retirement When No

Spouse at Retirement: A member, unmarried on the date of retirement, who later marries may provide SBP coverage for the first spouse acquired after retirement. The election request must be sent to the Defense Finance and Accounting Service and must arrive there prior to the first anniversary of the marriage.

DFAS cannot honor a request received after the first anniversary of the marriage. The marriage must last for at least one year before the member's spouse becomes eligible to receive the annuity. As an exception, the new spouse becomes an eligible beneficiary upon the birth of a child of the marriage born before the first anniversary.

If the member fails to elect SBP coverage for the first spouse acquired after retirement, divorces that spouse or that spouse dies, and the member later remarries, the member cannot elect coverage for that subsequent spouse because he/she failed to elect coverage for the first spouse acquired after retirement.

Non-Resident Alien Tax on SBP: Non-resident alien SBP beneficiaries living in foreign countries are subject to a withholding tax by the U.S. government on their monthly annuity. The withholding tax rate is 30 percent of the payable annuity.

The tax levy is not part of the SBP laws but results from individual tax treaties between the U.S. government and various foreign countries. The 30 percent is a fixed tax that must be withheld by DFAS; however, there may be tax treaties with individual countries that reduce or eliminate the 30 percent tax rate.

The US and Japan have such a tax treaty and submitting form W8BEN to DFAS will eliminate or reduce this tax. For more information, contact the Retiree Activities Office.
