## DAF COVID-19 Guidance: **Traveler APOE Fact Sheet**

Individuals traveling on military (or contract) airlift must provide documentation of COVID status prior to boarding. Additionally, some countries require a negative COVID test result within a specified timeframe (e.g. 72 hours) prior to arrival. Due to these requirements, there is a potential for you or family members to test positive while in transit to your final destination. This guidance provides information and links to answer questions you may have while traveling.

## **TRAVELER REQUIREMENTS:**

- Travelers must provide proof of COVID-19 status prior to boarding military airlift flights at Aerial Port of Embarkation at Baltimore-Washington International (BWI) and Seattle-Tacoma (SEATAC) International airports.
- Travelers arriving to the APOE without a valid negative COVID-19 test, vaccination, waiver, or proof of recovery from COVID-19, as required by their destination, will be denied travel.
- Travelers should get tested at their losing installation and arrive with test results in-hand at the APOE. If you are taking leave enroute to the APOE, you are responsible for scheduling a COVID test at a local military treatment facility or commercial lab.
- Travelers are responsible for meeting destination country-specific requirements. Information • on required documentation and destination country specific requirements can be found at https://www.amc.af.mil/Home/AMC-Travel-Site/Coronavirus/.
- You are still required to wear a face mask on flights and in the airport (and other public conveyances) as directed by the Centers for Disease Control and Prevention.

## WHAT TO DO IF YOU ARRIVE WITHOUT PROOF OF COVID STATUS:

- Travelers without proper documentation will most likely need to get tested in the local area.
- AMC Terminal staff will provide additional information on testing options near the airport:

- There are different types of COVID tests; a molecular (PCR) test is generally accepted in • most countries.
- For official travel, COVID tests are reimbursable. For leave and unofficial travel, you are responsible to cover the cost.
