Tax Center Will Open Soon: The Yokota Tax Center operated by the 374 AW Legal Office is gearing up for the 2018 tax season. The call for volunteer tax preparers has gone out and hopefully there will be enough volunteers available that all categories of DoD ID holders will be able to get assistance in preparing and electronically filing their 2018 tax returns.

Volunteers under the Volunteer Income Tax Assistance Program (VITA) will receive classroom training by an Internal Revenue Service (IRS) agent during the week of January 14th. They will also be required to successfully pass various certification tests before they will be allowed to prepare tax returns.

Tax Center is scheduled to open in February, and will operate until June. It will be located in building 315, 1st floor as it has been in previous years. The exact time schedule as to hours of operations and days of the week the center will be opened has not been provided as of this writing. The number of volunteers and their availability will determine the exact schedule. This information, and when the center will start taking appointments will be provided when it becomes available. Preparing For Your Tax Appointment:

Depending on your particular tax situation, these are documents to bring to your appointment at the Tax Center. Depending on you tax situation, you may have forms and documents not listed here; so, if in doubt, bring them with you. - DoD ID card

- Social Security Cards/ITIN letter for you, your spouse and dependents

- A copy of last year's tax return if you did not prepare your taxes at the Yokota Tax Center.

- Any Form W2, Wage and Tax Statement
- Any Form 1099 (1099-R, 1099-INT, 1099-DIV, 1099-SSA), 1099-MISC)
- Any Form 1098
- Any Form 1042
- Form W2 Gambling Winnings

- Income and expense documents related to Rental Property

- Documents related to child care and dependent education expenses.

- Any other documents you have that might apply to your income taxes. (Source: Yokota Tax Center)
